As calculated in accordance with Rule 13d-3 of the Securities Exchange Act of 1934, as amended, (i) Sabby Healthcare Master Fund, Ltd. and Sabby Volatility Master Fund, Ltd. beneficially own 100,000 and 176,687 shares of the Issuer's common stock (common shares), respectively, representing approximately 2.65% and 4.68% of the Common Stock, respectively, and (ii) Sabby Management, LLC and Hal Mintz each beneficially own 276,687 shares of the common shares, representing approximately 7.33% of the common shares. Mr. Mintz indirectly owns 276,687 common shares in his capacity as manager of Sabby Management, LLC.
